You should understand that possession of a visa does not entitle you to enter the Republic of China upon arrival at port of entry if you are found otherwise inadmissible or if the visa is fraudulently obtained.

You should also understand that the Government of the Republic of China reserves the right to withhold the reason for the disapproval of any visa application.

You are not permitted to accept employment in the Republic of China without prior approval.

■ 因過境、觀光、探親、訪問、研習、洽辦工商業務或因其他事務而擬在中華民國境內作六個月以下停留者，請選填申請停留簽證。

Please choose to apply for a VISITOR VISA, if you intend to stay in the Republic of China for less than six months for the purpose of transit, sightseeing, visiting relatives, or conducting business or other activities.

■ 停留期限為六十天者，抵華後可於期限屆滿前，檢具有關文件向停留地縣、市警察局申請延長停留，每次得停留六十天，以二次為限。停留期限為二星期、三十天、或六十天並加註「不得延期」戳記者，非因不可抗力或其他重大事故，不得申請延期。

With a visitor visa, you may stay in the Republic of China for sixty days and may, on good grounds, apply at the nearest city/county police headquarters for a maximum of two extensions, each for sixty days. No extension of stay will be granted if the duration of stay is restricted to two weeks, thirty days, or sixty days with a restrictive stamp of "No Extension Will Be Granted", except for situation caused by force majeure or matter of vital importance.

■ 因依親、就學、應聘、投資、就醫、傳教或從事其他業務，而擬在中華民國境內作六個月以上居留者，請選填申請居留簽證。

Please choose to apply for a RESIDENT VISA, if you intend to stay in the Republic of China for more than six months for the purpose of joining family, pursuing studies, accepting employment, making investment, receiving medical treatment, doing missionary work, or engaging in other activities.

■ 持居留簽證來華者，須於入境後十五天內向居留地縣、市警察局申請外僑居留證。

Holding a resident visa, you are required to apply for an Alien Resident Certificate at the city/county police headquarters within fifteen days after entry into the Republic of China.
